Celebrating 10 years of working to ensure older people are fully recognised in society, and are supported and enabled to live well in an all-age friendly Commonwealth.



Commonwealth countries are diverse; they are among the world's biggest, smallest, richest and poorest countries, and of the 8 billion people alive today, 2.5 billion of them live in Commonwealth countries.

Despite the enormous diversity in population dynamics across the countries, with very few exceptions, they all share the global trend of ageing populations, with varying degrees of ageism evident within their civil societies.

This year we are celebrating 10 years of creating connections, sharing ideas and challenging ageism as we work towards an age-friendly Commonwealth

We are committed to ensuring that older people in the Commonwealth are fully recognised in their societies, and that they are supported and enabled to live well. We believe older people can continue to make a valuable contribution to the communities in which they live and that all generations should live and work together in peace and harmony in a truly inclusive Commonwealth.

We support the view that a healthy ageing population is much less expensive one for governments to support, and therefore is less of a burden on taxpayers and health systems.

By influencing government decision makers, making submissions to international papers and organisations, attending key Commonwealth and other international meetings, conferences and roundtables, we ensure the spotlight is on older people, that their human rights are respected, and that they have access to care and support regardless of age.

From our small beginnings, we now have representatives in over 25 Commonwealth countries. It is thanks to these dedicated people that we have achieved much over the past 10 years.

2017

 Our Bursary scheme enabled 6 professional colleagues from developing Commonwealth

countries to join us in Montreux to attend the Global Ageing Network/ Curaviva Global Ageing Conference, 18-21 September, Switzerland

 Reframing Residential Care seminar in collaboration with The Residential Forum, and hosted in London UK by Trowers & Hamlins LLP Launch of our Intergenerational story telling project, with the aim of connecting all ages across the Commonwealth, combating ageism and recording life stories pf older people. The project took the form of a competition; young people living in Commonwealth countries were invited to spend time with an older person and write that person's life story, and their own experience.

We commenced our strong support for the Independent Forum of Commonwealth Organisations (IFCO), guiding the relationship of accredited organisations with the Commonwealth Secretariat and other

Commonwealth institutions.



2019


 Our CEO presented CommonAge to delegates at the Alzheimer's International Asia Region Conference, Kuala Lumpur, August 2019.
